* PARTICIPANT HAS TO UPLOAD 1 (ONE) NO. OF UNEDITED VIDEOS OF THEIR RESPECTIVE AGE GROUP & BELT GRADE CATEGORIES STATED HERE IN THE AFOREMENTIONED SYLLABUS.

* THE JUDGEMENT OF SPEEDKICKING WILL BE ON THE BASIS OF KICKING SPEED, BODY BALANCE & POSITION AND HEIGHT OF THE KICK. FURTHER, THE KICKS UNDER BELT HEIGHT WILL NOT BE COUNTED.

* 60% SCORE WILL BE BASED ON KICKING SPEED, KICK COMBINATION & ACCURACY, 20% SCORE WILL BE ON BALANCE & RYTHAM, 10% WILL BE ON STAMINA AND REST 10% WILL BE CARRIED OUT ON THE BASIS OF PRESENTATION, STANDING POSITION (BACK & FRONT), DRESS-UP ALONG WITH CAMERA POSITION & VIDEO QUALITY.

* ALL VIDEOS SHOULD BE RECORDED UNDER CLEAR / PLAIN / SINGLE COLOUR BACKGROUND & UNDER SUFFICIENT LIGHTS TOO.

* PARTICIPANT HAS TO UPLOAD 2 (TWO) NOS. OF UNEDITED VIDEOS WITH 2 SEPARATE SELF DEFENSE TECHNIQUE. FURTHER, PARTICPANT HAS TO RECORD 1 (ONE) VIDEO IN OFFICIAL DOBOK & OTHER VIDEO WITH GENERAL OUTFIT OF THEIR OWN CHOICE.

* PARTICIPANT CAN USE DAILY USE GADGETS OR WEARING ACCESSORIES LIKE (PEN, BELT, DUPATTA & HAIR PIN ETC.) ANY SHARP WEAPONS LIKE KNIFE, SCISSORS OR CUTTERS ETC. SHOULD NOT BE USE & ON BREACH OF RULES VIDEOS WILL BE REJECTED.

* PARTICIPANTS CAN TAKE ASSISTANCE FROM HIS/HER ONE FAMILY MEMBER (MALE/FEMALE).

* CONVINIENT COMBINATIONS CAN BE (MALE + MALE / MALE + FEMALE OR FEMALE + FEMALE).

* 50% SCORE WILL BE BASED ON SELF DEFENSE TECHNIQUES, 20% SCORE WILL BE ON PRESENTATION & REST 30% WILL BE CARRIED OUT ON THE BASIS OF PERFECTION.

* ALL VIDEOS SHOULD BE RECORDED UNDER CLEAR / PLAIN / SINGLE COLOUR BACKGROUND & UNDER SUFFICIENT LIGHTS TOO.

TERMS & CONDITIONS (FOR TEAMS & PLAYERS)

* TEAM / CLUB REGISTRATION SHOULD BE COMPLETED BEFORE PLAYER REGISTRATION. TO AVOID INCONVINIENCE FILL THE FORM VERY CAREFULLY. FORM ONCE SUBMITTED CAN NOT BE EDITED.

* AFTER SUCCESSFUL COMPLETION OF TEAM REGISTRATION A TEAM CODE WILL BE GENERATED WHICH MUST BE NOTED CAREFULLY, WITHOUT THE TEAM CODE PLAYER REGISTRATION WILL NOT POSSIBLE. THOUGH AN EMAIL CONTAINING TEAM CODE WILL DELIVER AUTOMATICALLY TO THE GIVEN EMAIL ID DURING THE TEAM REGISTRATION.

* EACH PLAYER SHOULD GENERATE THEIR PLAYER REGISTRATION NO. USING THE TEAM CODE BEFORE FILLING UP THE EVENT FORM(S). PLAYERS SHOULD BE DIRECTED TO FILL THE EACH FORM VERY CAREFULLY & MUST NOTE THEIR REGISTRATION NO., USER NAME & PASSWORD VERY CAREFULLY BECAUSE FORM ONCE SUBMITTED CAN NOT BE MODIFIED. AN AUTO GENERATED EMAIL WILL DELIVER TO EACH PLAYER WITH ALL DETAILS OF THEIR REGISTRATION TO THE GIVEN EMAIL ID DURING PLAYER REGISTRATION.

* AFTER COMPLETION OF ALL REGISTRATION PROCESS TEAM HEAD CAN PAY THE FEES BY CLICKING ON THE PAYMENT LINK, WHERE THEY MUST ENTER THE TEAM CODE TO KNOW THEIR TOTAL PAYABLE AMOUNT & AFTER THAT THEY CAN PAY USING GIVEN OR CODE SCANNING / UPI ID / BANK TRANSFER MODE FROM ANY POPULAR PAYMENT APP LIKE GOOGEL PAY, PHONE PE, PAYTM ETC. FURTHER, AFTER COMPLETION OF PAYMENT, THE TRANSACTION ID & WITH SCREENSHOT OF THE SAME TO BE UPLOAD AND SUBMIT VIA PAYMENT LINK.

* NO PLAYER / PARTICIPANT CAN LOGIN TO THEIR DASHBOARD UNTILL PAYMENT IS NOT CONFIRM. FURTHER, REQUEST FOR PARTICIPATION WITHOUT PAYMENT / PAY LATER WILL NOT BE ENTERTAINED.
